**Tobacco Center of Regulatory Science on Youth and Young Adults (TCORS)**

The central focus of the Center is on research and training in tobacco regulatory science relevant to FDA's research priorities. It focuses on youth and young adults, the potential impact that tobacco marketing has on them, and methods to communicate tobacco risks.

### **TCORS – The Texas Adolescent Tobacco and Marketing Surveillance Study (TATAMS)**

### **Preventing Tobacco Use Among Youth in Uruguay: Project ¡Actíivate Ya!**

The goal of this study is to create and evaluate a multiple-component tobacco prevention and physical activity promotion intervention for adolescents in Montevideo, Uruguay (n=16 schools, n=3,200 adolescents). Capacity-building activities are included in the project, too.

### **Peers Against Tobacco**

The goal of this study is to create a computer-based tobacco prevention and cessation intervention for college students in Texas. This is one component of a multiple component project which will start with 16 colleges statewide and grow to cover many more in the state.

### **Brain Power! PLUS: A Science-Based Preventive Intervention for 4<sup>th</sup>-5<sup>th</sup> Graders**

Principal Investigator – Dell Center for Healthy Living – Pilot Grant – \$2,000 – 2012 to 2013

The purpose of this study is to collect pilot data in support of a future application to further develop and test the efficacy of a multiple-component, science-based drug prevention intervention for 4<sup>th</sup> and 5<sup>th</sup> graders called *Brain Power! PLUS* (n<200 youth, parents, teachers).

### **Preventing Tobacco Use Among Youth in Uruguay: Project ¡Actívate!**

The purpose of this study is to collect pilot data in support of an application to develop and test the efficacy of a multiple-component intervention to prevent tobacco use and promote physical activity for 7<sup>th</sup>-8<sup>th</sup> graders in Uruguay (n=2 schools, n<200 youth, parents, teachers).

### **Connecting Media Use and the Development of Obesity Across Childhood**

The goal of this project is to estimate growth curves of media use, physical activity, and weight status from early childhood to adolescence, evaluate associations among them, and identify moderators of the association between media use, physical activity and obesity.

### **Advancing Cessation of Tobacco Use in Vulnerable Indian Youth**

Principal Investigator – NIH/Fogarty – RO1 TW007933-01 – \$1,310,000 – 2007 to 2012

This study is a randomized controlled trial to develop and test the efficacy of a tobacco cessation/control intervention (ACTIVITY) for primarily out-of-school youth living in slums and resettlement colonies in Delhi, India (n=14 slum communities, n=8000 adolescents).

### **Surgeon General's Report: Preventing Tobacco Use Among Youth and Young Adults**

Co-Principal Investigator – CDC/OSH – \$667,864 – 2008 to 2012

This contract supports the development of the 2012 Surgeon General's Report on Tobacco Use, which will focus on prevention tobacco use among young people. This report shall update the 1994 Report of the same name, with a more global perspective on tobacco use.

### **Efficacy of Varenicline for Smokeless Tobacco Use in India**

Consultant (Robert Schnoll, PI) – NIH/NIDA – R21 – \$358,104 – 2009 to 2011

This study supported a clinical trial of the efficacy of varenicline, FDA-approved to reduce tobacco smoking, for smokeless tobacco use in India (n=237 smokeless tobacco user Delhi).

### **A Social Marketing Approach to Obesity Prevention in India**

Principal Investigator – UT School of Public Health – PRIME – \$49,982 – 2007 to 2010

This study supported the development of a social marketing intervention to promote both healthy eating and physical activity behaviors among youth in Private schools in Delhi, India. A mixed-methods (quantitative-qualitative) approach to doing research was utilized.

### **Dissemination of CATCH to Travis County Elementary Schools**

This study supported the dissemination of the CATCH program (Coordinated Approach To Children's Health), to elementary schools in Travis County, Texas (Austin, Texas).

This study supported the development of new measures (surveys) of dietary intake and physical activity for secondary school students in India (n=2 schools and n=200 students). These surveys will be used to evaluate subsequent obesity prevention programs for youth.

### **The Epidemiology and Etiology of Obesity among Youth in India**

Principal Investigator – U Minnesota, Obesity Prevention Center – \$10,000 – 2006 to 2007

This study was a cross-sectional survey designed to (a) estimate the prevalence of obesity and overweight in Indian youth; (b) elucidate behavioral factors related to high BMI; and (c) examine the association between “westernization” and these factors (n=1818 students).

### **Mobilizing Youth for Action Against Tobacco in India (MYTRI)**

Project Director (Perry, PI) – NIH/Fogarty – R01TW05952-01 - \$1,297,820 – 2002 to 2008

This study was a randomized controlled trial to develop and test the efficacy of MYTRI, a school-based, multiple-component intervention to prevent and reduce tobacco use among 6<sup>th</sup>-9<sup>th</sup> grade students in Delhi and Chennai, India (n=32 schools and n=15,000 students).

### **An Adaptation of Project Northland for Urban Youth**

This study was a randomized controlled trial to adapt and then test the efficacy of Project Northland, a community- and school-based intervention to prevent and reduce alcohol use among 6<sup>th</sup>-8<sup>th</sup> graders in low income Chicago schools (n=60 schools and n>5000 students).

### **The Minnesota D.A.R.E. Plus Project**
